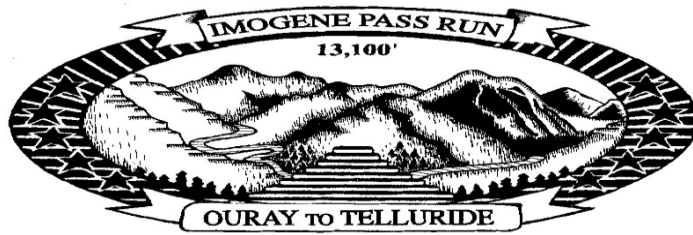

The Imogene Pass Run Cutoff time at Upper Camp Bird is 10:00 AM (2.5 hours for the first 7.5 miles). You must be able to run at a pace of 3.04 mph for the first 7.5 miles or you will not make the cutoff. We will also be disqualifying people who start the race early and do not record a start with their chip.

LIABILITY WAIVER, RELEASE AND AGREEMENT FOR THE IMOGENE PASS RUN

I understand and assume all risks of injury to my person which may occur while competing in the above named race of Imogene Pass Run, Inc., and/or the Imogene Pass Run (referred to as the IPR), and I, for myself and for my heirs, executor, administrator personal representative, and assigns, do hereby forever waive and release all rights and claims for direct or indirect damages or losses, whether monetary or otherwise compensatory which I may have against any and all individuals, employees, officers, sponsors, contract employees, committees, corporation, groups, the Town of Telluride, the City of Ouray, Alpine Bank, Telluride and Ouray EMT, Mt. Rescue Association, USATF, CJ Sports Timing and United States of America or above-named and unnamed parties harmless and indemnify them for all claims, damages, judgments, and cost of whatever nature and form.

I am advised that the following are some but not all of the special conditions and factors which may be encountered in the IPR and that there may be other hazards: Course elevations are from more than 7,800' to more than 13,100' above mean sea level with attendant low humidity and variable, extreme and rapid temperature changes. Severe storms may be encountered. Ultraviolet radiation exposure should be considered as extreme. The temperature may vary from 30 - 80 degree F in Ouray to 30 F and colder along the racecourse with high winds and possibility of lightning, rain, snow or ice showers likely (particularly above tree line). In general the weather should be considered variable with rapid and potentially extreme temperature changes, precipitation and wind. Most of the racecourse uses the Imogene Pass Road beginning on Hwy. 550 South of Ouray, Colorado and crosses a high mountain pass known as Imogene Pass continuing on to Telluride, Colorado. The road is a four-wheel drive road that is not paved. The travel surface may be dirt, gravel or rock, with abrupt elevation changes, sharp turns, steep grades and severe drop-offs. Ice or snow may be encountered on the road surface. The initial half-mile of the course is on paved streets and highway where there may be gravel deposited by rain runoff. The final two blocks of the course also is on a steep paved street that may have gravel deposited by rain of vehicular tires. Because of the inaccessibility of most portions of the course to motorized vehicles during inclement weather there may be delays in providing emergency medical assistance. Transport off the mount for IPR participants involves motor vehicles with attendant hazardous road conditions, mechanical failure or accident.

I attest that I am in good physical condition and mentally capable of participating in the race for which I am registering and that any and all questions about the race, including but not limited to the dangers of participating in said event, have been satisfactorily answered. I also acknowledge that should I require transport by vehicle, helicopter or fixed wing aircraft to a medical facility that I must pay for such transportation and any treatment provided. I further agree to abide by request of race officials on matters concerning race operations.

I understand that the IPR may not be started and may be shortened or cancelled at any time in progress as determined by IPR officials because of safety considerations. If I have not reached the cutoff point, as described in "conditions", or for my own safety I may be turned back to Ouray and I will not complete the race. If the Race Director and/or Sheriff's department closes the road over Imogene Pass, I will not proceed beyond that point.

I hereby grant full permission to any and all of the foregoing, whether named or unnamed entities to use my name, picture of likeness on any media or form and any other records of my participating in any or all events for any publicity and/or promotional purposes without obligation to me or my successors, assigns, et al., or liability by the publisher or promoter. I understand my name and address may be provided to sponsors for the purpose of product promotions.

I have read the entry information provided and certify my compliance with such by my signature below. Conduct on my part which if deemed to be un-sportsmanlike by the Race Director will be grounds for my immediate disqualification and denial of further participation in this and subsequent races organized by the IPR or the Imogene Pass Run Inc. I understand that the race entry fees paid by or for me are non-refundable unless the registrar refuses entry. The no-refund policy also applies to any cancellation of the race for weather or other circumstances. Race organizers will exercise due diligence in obtaining permits and providing services in support of the race.

I agree not to give, sell or otherwise transfer my official race number to any other person(s).

I agree not to bring or otherwise have animals on the course.

For and in consideration of USA Track & Field, Inc. ("USA Track & Field") allowing me, the undersigned, to participate in the USA Track & Field sanctioned event described above (the "Event" or "Events"); I, for myself, and on behalf of my spouse, children, guardians, heirs and next of kin, and any legal and personal representatives, executors, administrators, successors and assigns, hereby agree to and make the following contractual representations pursuant to this Waiver and Release of Liability, Assumption of Risk and Indemnity Agreement (the "Agreement");

- I hereby represent that (i) I am at least eighteen (18) years of age (or this Agreement is agreed to by my parent, natural guardian, or legal guardian (the "Guardian")); (ii) I am in good health and in proper physical condition to participate in the Event; and (iii) I am not under the influence of alcohol or any illicit or prescription drugs which would in any way impair my ability to safely participate in the Event. I agree that it is my sole responsibility to determine whether I am sufficiently fit and healthy enough to participate in the Event, that I am responsible for my own safety and well-being at all times and under all circumstances while at the Event site.
- I understand and acknowledge that participation in track & field, road running, race walking, cross country, mountain, ultra, and trail running Events is inherently dangerous and represents an extreme test of a person's physical and mental limits. I understand and acknowledge the risks and dangers associated with participation in the Event and sport of track & field and related activities, including without limitation, the potential for serious bodily injury, sickness and disease, permanent disability, paralysis and loss of life; loss of or damage to equipment/property; exposure to extreme conditions and circumstances; contact with other participants, spectators, animals or other natural or manmade objects; dangers arising from adverse weather conditions; imperfect course or track conditions; land, water and surface hazards; equipment failure; inadequate safety measures; participants of varying skill levels; situations beyond the immediate control of the Event Organizers; and other undefined, not readily foreseeable and presently unknown risks and dangers ("Risks"). I understand that these Risks may be caused in whole or in part by my own actions or inactions, the actions or inactions of others participating in the Event, or the negligent acts or omissions of the Released Parties defined below, and I hereby expressly assume all such Risks and responsibility for any damages, liabilities, losses or expenses which I incur as a result of my participation in any Event.
- I agree to be familiar with and to abide by the Rules and Regulations established for the Event, including but not limited to the Competition Rules adopted by USA Track & Field and any safety regulations established for the benefit of all participants. I accept sole responsibility for my own conduct and actions while participating in the Event, and the condition and adequacy of my equipment.
- I hereby release, waive and covenant not to sue, and further agree to indemnify, defend and hold harmless the following parties: USA Track & Field, Inc., its members, clubs, associations, sport disciplines and divisions; United States Olympic Committee (USOC); the event directors, the host organization and the facility, venue and property owners or operators upon which the Event takes place; and any other organizers, promoters, sponsors, advertisers, coaches and officials for this Event; law enforcement agencies and other public entities providing support for the Event; and each of their respective parent, subsidiary and affiliated companies, officers, directors, partners, shareholders, members, agents, employees and volunteers (Individually and collectively, the "Released Parties" or "Event Organizers"), with respect to any liability, claim(s), demand(s), cause(s) of action, damage(s), loss or expense (including court costs and attorneys' fees) of any kind or nature ("Liability") which may arise out of, result from, or relate in any way to my participation in the Event, including claims for Liability caused in whole or in part by the negligent acts or omissions of the Released Parties. I further agree that if, despite this Agreement, I, or anyone on my behalf, makes a claim for Liability against any of the Released Parties, I will indemnify, defend and hold harmless each of the Released Parties from any such Liabilities which any may be incurred as the result of such claim.
- As a condition of my participation in the Event, I hereby grant USA Track & Field, Inc., the event director and host organization a limited license to use my name, likeness, image, photograph, voice, video, athletic performance, biographical and other information (collectively, "Likeness"), in any media platform or format whatsoever, and to distribute, broadcast and exhibit these without charge, restriction or liability, but only for the purposes of advertising or promoting the Event, USATF, or the sport of Athletics. The foregoing grant, however, does not constitute consent for USATF or any third party to use my Likeness in an endorsement of any product or service without my specific written consent.

I hereby warrant that I (or the Guardian, if I am under the age of 18) am of legal age and competent to enter into this Agreement, that I have read this Agreement carefully, understand its terms and conditions, acknowledge that I will be giving up substantial legal rights by signing it (including the rights of my spouse, children, guardians, heirs and next of kin, and any legal and personal representatives, executors, administrators, successors and assigns), acknowledge that I have signed this Agreement without any inducement, assurance or guarantee, and intend for my signature to serve as confirmation of my complete and unconditional acceptance of the terms, conditions and provisions of this Agreement. This Agreement represents the complete understanding between the parties regarding these issues and no oral representations, statements or inducements have been made apart from this Agreement. If any provision of this Agreement is held to be unlawful, void, or for any reason unenforceable, then that provision shall be deemed severable from this Agreement and shall not affect the validity and enforceability of any remaining provisions.

If the participant is under the age of 18, the Guardian hereby agrees to release and discharge the Released Parties as follows: a) The Guardian acknowledges and understands that the Event is inherently dangerous and represents an extreme test of a person's physical and mental limits. Further, the Guardian acknowledges and understands the Risks, as defined above. b) The Guardian acknowledges the rights waived by both the Guardian and the participant by accepting this Agreement. c) The Guardian acknowledges that the Guardian will indemnify the Released Parties from any and all Liability which may arise out of, result from, or relate in any way to the participant's participation in the Event, including claims for Liability caused in whole or in part by the negligent acts or omissions of the Released Parties.
